## Dear Secretary Johanns:

As we enter the New Year, a range of vital issues are on the agenda in 2006 for America's cattle and beef industry, including trade negotiations, health and safety standards for imports and exports of cattle and beef, ongoing efforts to launch a national animal identification system (NAIS), the need to implement country-of-origin labeling for beef, and renewal of the farm bill, among other issues. We recognize the enormous amount of work that lies ahead for USDA on these issues, and know that you, like R-CALF USA, appreciate the vital importance of the cattle and beef sector to the American agricultural economy and rural communities all over this nation, and are striving to find the right policy solutions for America's agriculture community.

We understand that you may soon be putting forward a nominee for the Under Secretary for Marketing and Regulatory Programs at USDA, who will play a crucial leadership role in these on-going policy debates. The former Under Secretary, William T. Hawks, has a proud record of service, and he leaves behind big boots to fill. We are writing to share our thoughts on factors worth considering in making this important decision.

To help build consensus around policy solutions for the cattle and beef sector, an Under Secretary must be able to balance the needs of producers, processors, and consumers. USDA needs high-level leadership that not only represents the best in technical expertise and experience, but can bridge the different interests and points of view of the various segments of agriculture. A variety of backgrounds and perspective must be represented. For example, it is important that any nominee be accessible to producers as well as processors, both of which need a voice in policy deliberations at USDA.

Many in producer agriculture, along with government watchdog groups and the media, have expressed concern that such high standards of neutrality, independence and balance are not being met fully. In particular, questions have been raised about overrepresentation of processors and large agribusiness in USDA appointments, to the exclusion of those with a background reflecting the interests of small and independent producers. In the cattle and beef sector, for example, numerous former representatives of the National Cattleman's Beef Association have been brought in to important USDA posts, while many independent cattle producers feel shut out of USDA decision-making. These perceptions only make it that much harder to bring different segments of agriculture together to find policy solutions that benefit our community as a whole and enjoy broad public support.

R-CALF USA appreciates your consideration of these factors as you move towards filling top positions within USDA. We would be happy to provide input to you on potential nominees for the Under Secretary position that bring expertise, experience, independence and a balanced approach to the many issues affecting America's cattle producers. Once your nominee is announced we hope to be able to express our support. We look forward to working with you on the many issues of mutual concern that lie ahead in the coming year.
